*** 2008-2009 Calendar notes:**

- * **Monday, June 16, 2008**, is the recommended Board meeting date to avoid a meeting date conflict with TASA's annual summer conference, scheduled for June 22-24. **No reserve date** is recommended in June.
- * **Monday, July 21, 2008**, is the recommended Board meeting date to accommodate Trustees' summer schedules. **No reserve date** is recommended in July since the District closes during the week of July 4.
- * **Monday, October 6, 2008**, is recommended as a **reserve date** rather than the traditional second Monday, October 13, which is Columbus Day and a student/teacher holiday.
- * **Monday, November 17, 2008**, is the recommended Board meeting date instead of the fourth Monday, November 24, due to Thanksgiving holidays. **No reserve date** is recommended in November.
- * **Monday, December 08, 2008**, is the recommended Board meeting date instead of the fourth Monday, December 22, due to Winter Break. **No reserve date** is recommended in December.
- * **Monday, January 12, 2009**, is the recommended Board meeting date instead of the fourth Monday, January 26, because of TASA's Mid-Winter Conference. Monday, January 19, was not recommended because it is MLK Jr. Day and a school holiday. **No reserve date** is recommended in January.
- * **Monday, March 30, 2009**, is the recommended Board meeting date because the fourth Monday, March 23, immediately follows Spring Break, March 16-20. Therefore, **no reserve date** is recommended in **March**. In addition, 2009 **Texas Public Schools Week** has been tentatively set for March 2-6 by the Texas School Public Relations Association. The Board has previously requested that Board meetings not be held during Texas Public Schools Week if at all possible.
- * **Monday, May 18, 2009**, complies with state law for canvassing results from Election Day, Saturday, May 9. Law states that the canvass can occur no earlier than the eighth day and no later than the eleventh day after the election. Also note that Memorial Day holiday occurs on May 25, the fourth Monday.
- * **No reserve date** is recommended in **June 2009**.
